Playing field

Review and approve quotes for annual hedge trim.

Review position with village defibrillators and donation to MAGPAS following free training provided.

RESOLVED: Agreed for £100 donation. Clerk to contact MAGPAS to complete grant funding form. Clerk confirmed a new defib unit is £1,000.00. All agreed to purchase another defib for installation outside village hall and enquire if the VHC can be responsible for installation and maintenance.

Review position of volunteer for speed camera charging.

RESOLVED: Defer until next meeting where full Council is present.
